Many NHSAA operational matters encumbered efforts and became necessary priorities last year. With these issues positively resolved, we are resolutely focused on improving our membership services and opportunities while continuing to evolve the Association.

Integral to shaping a positive future for the Association and NH's students is the Granite State Leadership Academy (GSLA). GSLA "fellows" currently sit in system leadership positions throughout the state. The ninth GSLA Cohort is composed of over a dozen aspiring and current system leaders. Seeking enhanced growth opportunities, GSLA participants will be asked to investigate and engage in a local "Possibility of Practice" during their GSLA experience. This is an opportunity to put theory into practice and have a positive impact on their local learning community. Thank you all for your support of the GSLA. We'll begin our recruiting efforts for GSLA Cohort X before you know it. To that end, please have an eye out for aspiring and future leaders in your respective districts.

On the topic of system leadership, as the NHSAA continues to collaborate with partner organizations, among our priorities this year is superintendent licensing and coaching / mentoring. Last year, we began productive conversations with the NHED regarding the Ed 500 rules, site-based plans, and superintendent licenses. Sometimes these discussions are akin to turning an oil tanker; however, positive progress was made! We will re-engage in these pertinent conversations this year. The vital importance of growing our own future leaders cannot be overstated. Relatedly, NHSAA PD sessions (via attendance and / or presenting) are another great way to begin the process of cultivating the next "batch" of impactful system leaders!

We will continue to strive to effectively represent the NHSAA in NH's legislative process as well. We've already begun strategizing and connecting with various partner organizations, representatives, and leaders. Along with the gubernatorial race, there are 424 House and Senate elections in NH local government this year! Establishing professional relationships with our local decision makers will undoubtedly help as we attempt to have the "credible voice of education leadership" cut through the cacophony at 33 North State Street. While ideologies differ, we can (hopefully) find a common ground where we can agree to support NH's public education students, families, communities, and employees. That common ground could potentially serve as a place where ears are (more) open and folks are willing to see and appreciate various perspectives. We are optimistic!

Throughout the year, we hope to hear about and celebrate the achievements in your schools and districts as well. As part of that effort, the NHSAA is collaborating with kartoonEDU to produce a 5-part pro-public education video series. The first video in that series was last year's 306 video. The next video highlights district and community initiatives aimed at identifying a "Portrait of a Learner" or graduate. Throughout the year, other videos will be released. These videos will be FREE to NHSAA member districts. Additionally, a "steeply discounted" price for local branding and light editing will be offered to member districts. Associate Executive Director's Report

I hope each of you has had an opportunity over the summer to reflect on the successes of the previous school year and create your vision for the year ahead.

Professionally, the past year has brought renewed energy, commitment, and drive to the NHSAA office. We have experienced some logo rebranding, retooling of member management systems, and a sharp focus on member services and support.

Personally, these past few months, Joan and I celebrated our 50th year of marriage (how she has put up with me that long is anybody's guess), the birth of our 8th grandchild, and the passing of our 15-year-old shar pei. It is amusing to be part of conversations with our members when they speak of their children graduating high school or college, and we find our two oldest grandchildren entering high school this fall.

I want to take this newsletter as an opportunity to share part of my vision for the year ahead and invite each of you to engage in this journey to benefit kids.

My "Vision" for the 2024-25 School Year

Thanks to the efforts of their local public school system leadership, 8100 NH families will be enrolled in the T-Mobile "Project 10 Million" free hotspot and data initiative by June 2025. For the next five years, they will enjoy free internet access and 100 GB of data each year.

By September 2025, thanks to the efforts of school system leaders, NH kids will be fed two meals each day available at school (breakfast after the bell) and lunch, supported by state and federal funding so that no child is hungry, and local taxpayers are not the "bailout" plan for school lunch debt.

By October 2024, More districts participate in the School Breakfast Challenge, increasing the number of kids eating breakfast.

By October 30, 2024, All our members will be aware of the Food Access Coalitions and Councils in their region.

By October 30, 2024, every school website will have digital access to Free and Reduced-Price lunch applications, and each school district will experience a higher application rate.

By November 1, 2024. Each school has a sustained food pantry for weekend support to families

By April 2025, more schools will participate in the Community Eligibility Provision (CEP), which eliminates unpaid meal charges and allows eligible schools to offer free breakfast and lunch to all students at NO CHARGE. Only two of the 90 NH schools that are eligible participate in the CEP Program. Also in the same timeframe, Identify the barriers for schools and seek solutions to increase participation.

Associate Executive Director's Report - *continued*

By the end of this legislative session, each child is directly certified for free or reduced meals if they live in a SNAP or Temporary Assistance for Needy Family Household, are homeless, in foster care, or are in any other categorically eligible program (Medicaid Direct) that will qualify them for free or reduced meals.

Ensure that all children whose family income is up to 200% of the federal poverty level can eat free breakfast and lunch at school.

Summer meal programs and academic support are available for any child who needs and requests them in the summer of 2025.

By June 1, 2025, every district had contributed content to the PR Campaign to promote the value of public schools.

As true champions for children, what greater gift could we give our students than ensuring they have increased access to food and improved home internet connectivity for our most disadvantaged families? What could be a more tangible contribution toward equity? Why not us? Why not now? We are better together.


